Articles of Organization

(General Laws, Chapter 180)

ARTICLE I

The exact name of the corporation is:

SUMMIT TO SUCCESS, INC.

ARTICLE II

The purpose of the corporation is to engage in the following business activities:

THE CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE AND EDUCATIONAL PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE. NO PART OF THE NET EARNINGS SHALL INURE TO THE BENEFIT OF ANY PRIVATE INDIVIDUAL, AND THE CORPORATION SHALL NOT CARRY ON ACTIVITIES NOT PERMITTED TO ORGANIZATIONS EXEMPT UNDER SECTION 501(C)(3). THESE PURPOSES INCLUDE, BUT ARE NOT LIMITED TO, PROVIDING SCHOLARSHIPS, EDUCATIONAL MATERIALS, MENTORSHIP, AND SUPPORT PROGRAMS TO UNDERSERVED STUDENTS IN THE UNITED STATES, NEPAL, AND OTHER INTERNATIONAL LOCATIONS. THE CORPORATION MAY CONDUCT ITS ACTIVITIES IN ANY STATE, TERRITORY, OR COUNTRY, SUBJECT TO COMPLIANCE WITH APPLICABLE LAWS. THE CORPORATION MAY ALSO CARRY OUT ITS MISSION THROUGH DIRECT PROGRAMS, PARTNERSHIPS WITH SCHOOLS AND NONPROFITS, GRANTS, OR OTHER CHARITABLE MEANS AS DETERMINED BY THE BOARD OF DIRECTORS. UPON THE DISSOLUTION OF THE CORPORATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT OR TO A STATE OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE.

ARTICLE III

A corporation may have one or more classes of members. If it does, the designation of such classes, the manner of election or appointments, the duration of membership and the qualifications and rights, including voting rights, of the members of each class, may be set forth in the by-laws of the corporation or may be set forth below:

ARTICLE IV

Other lawful provisions, if any, for the conduct and regulation of the business and affairs of the corporation, for its voluntary dissolution, or for limiting, defining, or regulating the powers of the corporation, or of its directors or members, or of any class of members, are as follows:

NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF OR BE DISTRIBUTABLE TO ITS DIRECTORS, OFFICERS, OR OTHER PRIVATE PERSONS EXCEPT THAT THE

CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF ITS PURPOSES. UPON THE DISSOLUTION OF THE CORPORATION ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT OR TO A STATE OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY A COURT OF COMPETENT JURISDICTION EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATIONS AS SAID COURT SHALL DETERMINE WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.

Notes: The preceding four (4) articles are considered to be permanent and may only be changed by filing appropriate Articles of Amendment.

#### ARTICLE V

The by-laws of the corporation have been duly adopted and the initial directors, president, treasurer and clerk or other presiding, financial or recording officers, whose names are set out on the following page, have been duly elected.

#### ARTICLE VI

The effective date of organization of the corporation shall be the date approved and filed by the Secretary of the Commonwealth. If a later effective date is desired, specify such date which shall not be more than thirty (30) days after the date of filing.


